



# RULES OF PARTICIPATION

## 1. PRELIMINARY CONDITIONS

Timișoara Penitentiary of the National Administration of Penitentiaries as organizer in cooperation with The Association for Helping Children with Haemato-Oncology Disease “Patricia Popa” organizes **International Art Exhibition** having the theme : ”**Human in the Mirror**“.

The aim of this exhibition is a charity and the money generated from the works will be offered by **The Association for Helping Children with Haemato-Oncology Disease “Patricia Popa”** to the Department of Paediatric Oncology of the LOUIS TURCANU Hospital in Timisoara to purchase medical equipment.

The exhibition is also a competition aims to increase awareness and general knowledge of persons deprived of liberty; development and stimulation of expressiveness and creativity.

The exhibition is held in the following sections: painting, graphic and photography.

### *A. Painting section*

- Composition having as inspiration the **Human in the mirror**, using techniques and specific manners of oil painting, temper, gouache, acrylic, mixed media;
- Support of the artwork can be cloth on chassis, cardboard, paper and must fit the maximum size of 60x80 ;

### *B. Graphic section*

- Achieve a composition having as inspiration the **Human in the mirror**, using techniques, materials and specific manners of Graphic Arts (pencil, charcoal, ink , water colours, crayons, pastel);
- Maximum media size 60x80 .

### *C. Photography section*

- Images having the theme of **Human in the mirror**, black and white, colour or transferred to some dominant colour, processed in various digital postprocessing programs or presented in technical dates of the shooting, according to their own concepts of plasticity photo.
- Sizes of the Photos can be chosen according to artistic strategy of each participant;
- Artworks can be collages .

## 2. DEADLINES

-Launching ”Human in the mirror“ competition by informing the Directorate of Social Reintegration of the National Administration of Penitentiaries : **July 1, 2014**;

- Informing social reintegration services of the European and Romanian prisons, sending invitations



and event promoting in penitentiaries: **July 10, 2014 - August 15, 2014;**

- Requesting confirmations of participation from institutions where the invitations were sent: **August 16, 2014 - 30th of September 2014;**

- Sending and arriving of the participating artworks at Timisoara Penitentiary - prison organizer: **August 16, 2014 - 30th of September 2014 (the deadline of September 30, 2014 );**

- Media Promoting the exhibition: **October 1, 2014 - October 19, 2014;**

- Establishing the varnishing ceremony of the exhibition, judging the artworks, pricing: **October 20, 2014;**

- Announcing the results, providing certificates and diplomas of participation, sending them to owners: **October 21, 2014 - October 31, 2014;**

- Watching the exhibition by the interested public: **October 20, 2014 - October 24, 2014;**

- Selling the artworks: **October 20, 2014 - November 30, 2014;**

- Donating money to "LOUIS ȚURCANU" Children's Hospital, Paediatric Clinic II, Bone marrow Transplant Centre

### **3. TARGET**

- Inmates incarcerated in prisons in Europe;

- Inmates incarcerated in the establishments of the Romanian penitentiary system.

### **4. JUDGING AND AWARDING THE ARTWORKS**

- The jury will be composed of teachers of the Faculty of Arts and Design, artists and theorists recognized in the field and representative personalities from Timisoara.

- The winning artworks will be announced electronically. Evaluation criteria: originality, presentation of the subject, quality design. The jury's decision is final and can not be challenged.

### **5. EXHIBITION OPENING : OCTOBER 20, 2014**

### **6. FEES**

-No fees for participation, transportation and delivery cost will be borne by the participants or institutions that represent them and will not be refunded.



## 7. SPECIFICATIONS

Maximum 3 artworks for each participant (painting, graphic art or photography); unlimited number of each prison unit.

## 8. MAXIMUM SIZE

Up to 60x 80, if possibly framed or Passepartout/mounted, paintings must be hung .

## 9. LABELING OF ARTWORKS

Participant's name, nationality, country of residence name/address of the prison, title, signature, work technique, name of the coordinator (psychologist, educator, social worker).

## 10. CERTIFICATES

Each participant receives a certificate of participation, awarded works will receive diplomas and personalized plaques .

## 11. TERMS AND CONDITIONS

The participant declares that the work was created by him/her and that he/she owns all the rights to the artwork. Timisoara Penitentiary has permission to publish the artwork free with recognition as the author of the work. Copyright remains legally to the artist .

The participant declares that he/she owns all the rights to the artwork and has unlimited exploitation rights, the work does not infringe the rights of third parties and that when people appear in works, no personal rights are violated.

We accept no liability in case of damage or loss.

The artworks will not be returned and by exposure they become the property of the organizing institution - Timisoara Penitentiary. For reasons of data protection, anonymity is guaranteed at the written request of the author.

The author declares that the works have not been exhibited previously in a public exhibition or have not been published.

The organizer ensures that money resulted from sales will be donated to purchase medical equipment in the Bone Marrow Transplant Centre of the "LOUIS ȚURCANU" Children's Hospital - Department of Paediatrics Oncology.

By signing the sheet participation, the authors agree with the terms and conditions.

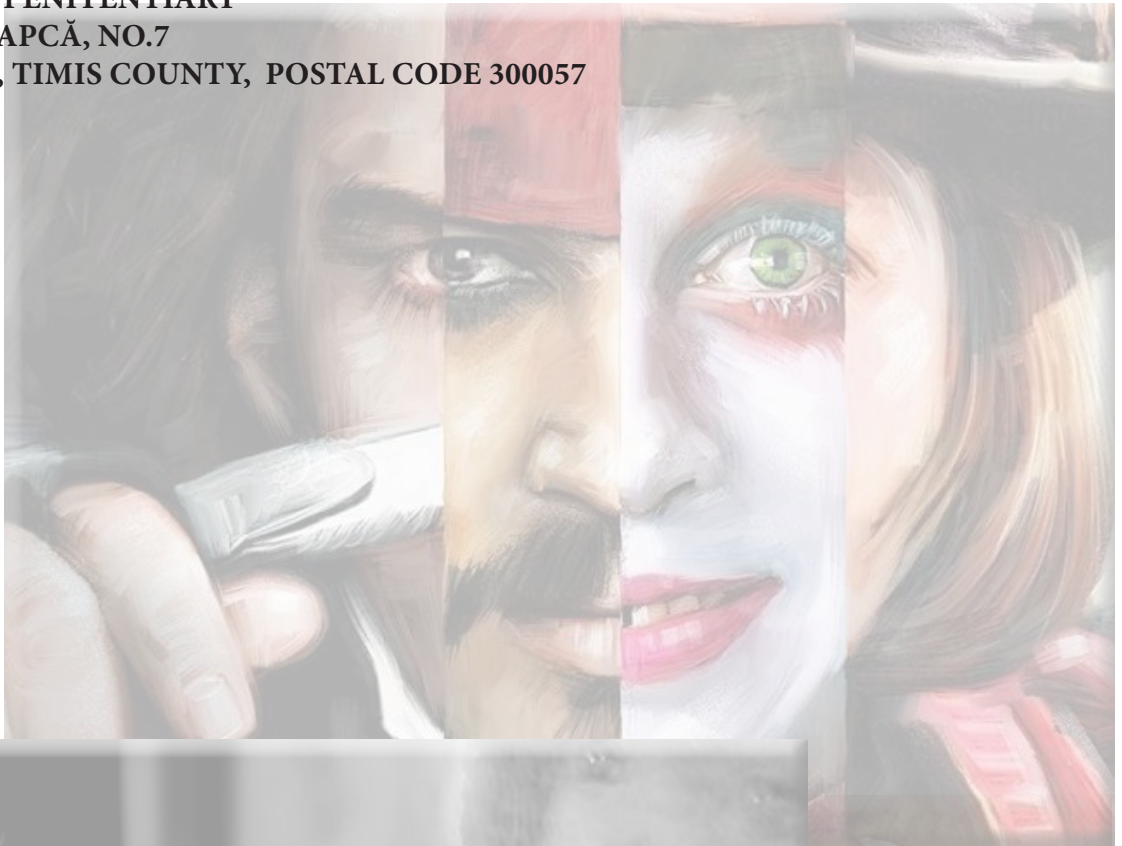


## 12 . SHEET OF PARTICIPATION
