#### 1. EuroPris General

2015 was the fourth year that EuroPris is up and running. There was a stable membership number for the past three years. During these past three years the Board and Secretariat were actively promoting the organization throughout Europe to interest more Prison Services to join the organization. In 2015 the organization experienced a steep rise and grew from 19 to 26 members, an increase of almost 40%. This demonstrates that the work of EuroPris is appreciated by European Prison Services and it is a motivation to continue on the chosen path.

EuroPris built further on the success of the expert group meetings and also started two new groups. Also, all of the existing groups were renewed in order to give the new members an opportunity to join them. And in order to allow for a wider sharing the expert groups all committed to produce good practice reports on selected subjects that will be shared with all EuroPris members and also presented at the Annual General Meeting. However, the networking opportunities that these meetings offer continue to be a very valuable aspect.

EuroPris is an inside and outside networking organization. Inside, meaning between our members and other European Prison Services. Outside, meaning with other related organizations. EuroPris demonstrated the ability to organize successful events and bring together experts from a wide variety of backgrounds and organizations. Other network organizations approached EuroPris to find ways of cooperation. With EuroPris becoming more known and visible we also receive an increasing number of requests, to support events with specific experts and with presentations about the work of EuroPris.

This also resulted in an increasing number of requests to participate in multilateral European funded cooperation projects. EuroPris started being a partner in such projects in 2014 and was active in six projects in 2015. Even if the role of EuroPris in such projects is limited, it requires good consideration before joining into these obligations. Projects should present in the first place an enhanced value for EuroPris members and they should have links with the EuroPris objectives and activities.

It is important that the European Prison Information System (EPIS) is populated with as many as possible up-to-date data. 15 jurisdictions provided at the end of 2015 their data. To further increase understanding of EPIS and stimulate the provision of data and use of EPIS a training was organized. The Knowledge Management System (KMS) proved to be an efficient tool to get answers on pressing issues. EuroPris received 29 requests from EuroPris members that were answered by an average of 14 Prison Services.

The European Commission selected EuroPris as one of their Framework Partners for 2015-2017 and to receive the Operating Grant in 2015. That also meant that EuroPris had to plan some of its work in accordance with the priorities of the European Commission. EuroPris participates at meetings of the Council of Europe Penological Council and contributed actively to their work at the meetings.

On the EuroPris website and in the bi-monthly newsletter EuroPris reported extensively about the work that EuroPris is doing and on other items or events that are relevant for the members and the network. The number of readers have been growing on the digital as well as followers on social media on Twitter and LinkedIn.

#### 2. EuroPris objectives in 2015

#### 2.1 Strengthen EuroPris' Role as a 'Centre of Expertise' in European Prisons and Corrections

The facilitation of the exchange of knowledge and good practice between prison practitioners was one of the main reasons for establishing EuroPris and is therefore one of the core objectives of EuroPris. It aims at the advancement of operational capabilities and professionalism of prison practitioners across Europe. The importance of networking and personal contact as a side effect of the events cannot be underestimated.

Main tool to work on this objective is the organization of expert meetings, workshops and conferences. Other important elements are the collection of operational information in a database (EPIS), the continue updating of the experts database and the possibility to consult other members on specific issues (KMS).

In the expert meetings a small group of experts can enter into a direct exchange on specific topics relevant for their jurisdictions. Since the number of EuroPris members largely increased in 2015 not all interested member jurisdictions could participate in each expert group. Therefore, expert groups started to work with Terms of Reference that can be shared with all EuroPris members. Each group presented their work at the Annual General Meeting.

The procedure for selecting experts for participation in these groups, ensuring a broad representation, was agreed by the Board and presented to the Annual General Meeting in Bucharest 2015.

Workshops were organized (often with the support of the concerned expert group) to share and discuss relevant topics with a wider group of prison experts. Workshops could also be attended by non-members, but were exclusively for public sector with some participation of universities and NGOs (depending on the topic). Such events were often the starting point for future networking between the participating experts. In 2015 one workshop was organized in cooperation with CEP on Staff Training with a focus on e-learning methods.

In 2015 EuroPris organized six expert group meetings. Two meetings were on the Framework Decision 909 and organized on request of the European Commission for all 28 EU Member States.

A new initiative introduced in 2015 was the organization of the Technology in Corrections conference in cooperation with ICPA and CEP. Aim of the conference was to challenge the private sector to present technological solutions to problems that the public sector is facing. As a result of the positive response from all participants it was decided to continue with the organization of this conference in 2017.

The EuroPris Annual General Meeting was preceded by a half day conference with presentations on radicalization and the outcomes of the EuroPris radicalization questionnaire (KMS). Next to that the EuroPris expert groups presented the outcome of their work in the previous year.

#### 2.2 Position EuroPris in a network of related organisations and European bodies

EuroPris aims to be the European network organization for Prison Services of the Council of Europe region. However, there are many other organizations and initiatives that are active in this field on a European level. Most of them focus on a specific subject in relation to prisons and prisoners. EuroPris is seeking to cooperate with these organizations and to establish links between the different prison related initiatives. This way EuroPris wants to strengthen its position as a central knowledge hub on European prison development and prison activities. Building this network with related organizations will help to prevent duplication of actions taken and provide for reaching out to a wider range of prison professionals.

In 2015 EuroPris participated in the annual conference of the European Prison Training Academies (EPTA) and the European Prison Education Association (EPEA). With EPTA discussions were continued about closer cooperation to increase the efficiency of the network. Similar discussions were ongoing with the European Prison Regime Forum (EPRF) since its last workshop in 2014. Close contacts were continued with Children of Prisoners Europe (COPE). EuroPris also kept contact with the Prison and Probation Working Group of the Radicalisation Awareness Network.

Another way of linking and cooperation was the participation in multilateral EU funded cooperation projects. In 2015 EuroPris participated in 6 projects. The role of EuroPris was mainly dissemination, sharing of the project outcomes and sourcing experts. Some of the projects activities were closely linked to the work of our expert groups, such as the FD 909 expert group and the STEPS 2 Resettlement project.

As a strong supporter and promoter of the European Prison Rules and Recommendations of the Council of Europe EuroPris participated as observer at the Council for Penological Cooperation (PCCP) and the Annual Conference of Prison and Probation Directors (CDPPS). EuroPris provided input to the discussions at the PCCP and to the agenda of the CDPPS. With the current focus of the Council of Europe on the implementation of the Recommendations, EuroPris presented a research to the plenary PCCP meeting on the implementation of the 2012 Recommendation on Foreign National Prisoners.

Having the European Commission as the main funder of EuroPris in 2015, the priorities of the European Commission were included into the annual work program of EuroPris. The implementation of the Framework Decision 909 on transfer of prisoners was one of the priorities that were supported with the organisation of two large expert meetings and a Criminal Justice Platform (CJP) seminar that discussed the implementation of FD 909 / 947 / 829. Based on the discussions of the FD 909 expert group a report was drafted on the FD 909 implementation that will be published in the beginning of 2016. Radicalisation was a sudden new high priority of the EC in 2015. EuroPris addressed this through the establishment of an expert group, through addressing this topic at the Annual EuroPris conference and through organizing a workshop on this subject with the CJP.

The Criminal Justice Platform (CJP) is the cooperation of three organizations: EuroPris, CEP and European Forum for Restorative Justice. The Platform is supported by the Ministry of Justice of Catalonia. The Platform organized three events in 2015: on the implementation of the EU Victims Directive, on Radicalisation and on the Framework Decisions 909/947/829.

# 2.3 Consolidate EuroPris' position as European representative organisation in the field of Prison and Correctional Services

EuroPris is a membership organization. Members can only be the Prison Service within a jurisdiction. Members can be Full (EU and EEA only) and Affiliate (whole Council of Europe region). EuroPris has a potential membership of some 35 full member jurisdictions (28 EU, 4 EEA and 3 devolved jurisdictions) and a further 15 affiliate members from the Council of Europe region. At the end of 2015 EuroPris consisted of 26 members, which were 24 full members and two affiliate members (Georgia and Turkey). Compared to 2014, when EuroPris consisted of 19 members, this is a major increase (37%) in membership. This growing interest of membership strengthened EuroPris' position as a representative organisation of European Prison Services.

In 2015 most of the Board member positions were open for re-election. This election also opened the opportunity to increase the size of the Board to its maximum of 10 and to include representatives of some of the new regions and members in Europe. As the nominations equaled the number of positions, all nominated Board members were elected at the Annual General Meeting. The AGM also approved the reports, planning and budget of EuroPris as presented.

The Secretariat was able to get some additional support in 2015. NOMS supported the organization with one staff member for one day per week. In the beginning of 2015 Craig Georgiou was replaced by Victoria Elliott to work on the FD 909 expert group. Nick Hammond retired from NOMS and volunteered since July for managing the Foreign National Prisoner expert group, of which he was a founding member. The office in Brussels was supported by two interns in the course of the year. With the increasing number of members and activities it was beneficial for the Secretariat to involve part time staff that worked on specific subjects. The Secretariat has been established as a solid organizational foundation that is able to anchor the ambitions of EuroPris.

#### 3. Activities and results in 2015

#### 3.1 Strengthen EuroPris' Role as a 'Centre for Expertise' in European Prisons and Corrections

In 2015 the Annual General Meeting decided upon the establishment of three new expert groups: radicalization, real estate & logistics and family relations. The first two started in 2015 and the third one will be launched in 2016. After a call for nominations of expert group members for ICT, Radicalisation, Real estate & logistics and FNP was launched the experts were chosen.

For each expert group Terms of Reference for a two year term were drafted. The tasks included in the Terms will provide for a wider sharing of the work of the expert group with the other members of EuroPris. It includes the production of reports on good practice and case studies or practical recommendations. The expert groups also give advice for the contents of the workshops that are organized on their specific subject.

#### Expert groups, workshops and conferences

During 2015 EuroPris organized expert meetings and workshops on the following topics:

- Framework Decision 909 on the Transfer of Prisoners: 2 expert meetings (all EU MS)
- Research and Statistics: EPIS training
- Staff training and development (in cooperation with CEP): workshop
- Foreign Nationals in prison (in cooperation with CEP): expert meeting
- ICT in Prisons: expert meeting
- Radicalisation: expert meeting
- Real estate & logistics: expert meeting

#### Foreign Nationals in Prison

#### Expert meeting

The topic of Foreign Nationals was jointly taken up by CEP and EuroPris. The group met at the beginning of 2015 to discuss a follow up to the 2014 workshop. The expert meeting was linked with the 10th Anniversary conference of the organisation Education behind Foreign Bars. The next day the EuroPris/CEP expert group met in Amersfoort, Netherlands to plan their activities for 2015.

Building on the intentions of the Council of Europe to evaluate the implementation of their recommendations, the expert group came after the meeting to an agreement with the CoE to provide a presentation to the plenary session of the Council for Penological Cooperation (PCCP) on the implementation of the 2012 Recommendation on Foreign Nationals. This presentation was given to the plenary meeting of the PCCP in November 2015 by Roisin Mulgrew (Nottingham university) and based on a study of Foreign Nationals only prisons in Norway and the Netherlands.

Mulgrew applied later in the year for funding of a practice oriented prison staff training on the CoE recommendation at Nottingham University. The application was submitted in November.

Based on the nominations for the expert group new members were selected from prison services of Denmark, Sweden, Croatia and Belgium.

#### Framework Decision 909 (FD 909)

#### Expert meeting

EuroPris has been supporting the implementation of the EU Framework Decision 2008/909/JHA on the transfer of prisoners from the very beginning of EuroPris. In the past years a limited number of experts were invited to these meetings. In 2015 – in consideration with the European Commission – a different approach was taken.

All EU Member States were invited to send one representative to the expert meeting. In order to keep the meeting manageable and provide for roundtable discussion the experts were divided in two groups. One meeting took place in Brussels and the other meeting two month later in The Hague. At both meetings experts from the STEPS 2 Resettlement project shared the project outcomes and collected input for the project. Amongst others, an e-learning module developed under STEPS2 was tested with all participants.

The experts discussed issues like obtaining consent, information provision to prisoners, sentence adaptation. A detailed report will be published in the beginning of 2016. The experts also agreed on EuroPris collecting numbers of in- and outgoing transfers under FD 909 and the numbers of EU citizens in all EU prisons. Next to the topical exchange the experts found it very valuable to meet their counterparts in person.

EuroPris continued to publish the Prisoner Transfer Information form on the website.

#### Research and Statistics

#### EPIS training

The European Prison Information System (EPIS) was officially launched at the 2014 AGM. Each jurisdiction needs to feed the data into the system themselves and update it once a year. In order to increase the understanding of EPIS and to motivate Prison Services to complete the data, EuroPris organized the European Prison Information System (EPIS) Training workshop at the Irish Prison Service College in Portlaoise, Ireland. The group was comprised of representatives from 10 European National Agencies (Bulgaria, Catalonia, Czech Republic, Ireland, Latvia, Lithuania, Norway, Turkey, Austria, and Germany). The training covered an introduction to EPIS, explanation of the different categories of data, practicalities and developments. Participants considered the training very useful, giving them a broader and better understanding on how to complete the data and how to use the system. Participants also provided input for the future improvements of the system.

#### Real estate & Logistics

#### Expert group

The initiative for the first meeting of this expert group was taken by the Netherlands and Belgian Prison Administration and was hosted in November 2015 by the Portuguese Prison and Probation Service. The group comprised of representatives from 11 European National Agencies (Belgium, Netherlands, Portugal, England, Czech Republic, Finland, Lithuania, Northern Ireland, Slovenia and Turkey). This first meeting was mainly intended to give the experts the opportunity to share details of their current work, current developments and best practices. The chairs from the Netherlands and Belgium decided to organize an additional meeting in the beginning of 2016 for in-depth discussions and the preparation of a paper on two selected topics:

- Public Private Partnership and contract management;
- influence of design and architecture on good prison management.

#### **Radicalisation**

#### Expert group

Radicalisation has been high on the agenda everywhere in Europe in 2015. Many initiatives were taken on bi- and multilateral level. And with the specific focus on prisons in relation to radicalization EuroPris decided to establish an expert group in order to elaborate what kind of support prison practitioners need. The first meeting was hosted in November in Vienna by the Austrian Ministry of Justice. The meeting was attended by representatives from 9 European National Agencies (Austria, Germany, Norway, Catalonia, Northern Ireland, Estonia, Bulgaria, and Turkey). The level of experience and the needs of the group varied widely, which seemed to be a good reflection of the situation throughout Europe. At the meeting participated also a representative from UNODC that started work on a 'Handbook on the management of violent extremist prisoners and the prevention of radicalization to violence in prisons'.

After sharing the situation in their jurisdictions and their challenges and needs, the experts decided to work on good practice papers that deal with risk assessment tools, identification of radicalised offenders and with the use of chaplaincy.

#### Staff training and development

#### Workshop

EuroPris and CEP work jointly on the topic of staff training. At the 2013 workshop it was decided that this would become a bi-annual event and thus a second workshop was organized in December 2015 in cooperation with the Irish Prison and Probation Service in Dublin.

In consideration with the Staff training expert group it was decided that the workshop would focus on just one topic to allow for in-depth discussions. The use of e-learning methods was decided to be of interest to most of the jurisdictions. The 51 participants to the workshop came from 22 jurisdictions. The workshop offered a mixture of academic presentations and sharing of experiences of very experienced e-learning providers and staff training academies that just started to experiment with e-learning. This sharing at different levels made the workshop attractive for a wide range of staff training centers. At a 'market place' the participants were given the opportunity to showcase and practice their e-learning programs on computers. Participants rated the workshop as very useful and inspiring.

#### **ICT** in Prisons

#### TIC conference

EuroPris in cooperation with ICPA and CEP organised in May 2015 the first Global Corrections Digital Technology Conference: 'Technology in Corrections: Challenges for the Future'. The conference was hosted by the Justice Department, Government of Catalonia. 200 participants (from prison and probation, universities and technology providers) from more than 34 countries joined in Barcelona to think and share their views on the future of prisons and probation and the increasing role of technology.

The purpose of this conference was to:

- Challenge the private sector to develop innovative digital solutions for use in corrections to address issues facing prisons and probation today;
- Provide networking opportunities for senior managers and technology experts in the corrections arena;
- To promote the use and implementation of advanced Digital Technology Solutions in corrections.

And the conference offered a platform for both public and private sectors to have discussions under three themes:

- Collaboration, knowledge and information management within the whole lifecycle of offender management
- Improve operational and security processes and the way we are working inside and outside prisons
- Collaboration and participation of the offender himself during this whole lifecycle.

11 companies presented their solution and entered into a dialogue the participants. Participants from public and private sector considered this conference a success that should be repeated in the future.

Next to the conference a sponsored market place was organized with were 12 private sector companies presented their equipment. The sponsor income of the event provided for an additional source of income for EuroPris in 2015.

#### Expert group

The 'old' expert group supported the organization of the TIC conference with advice on topics and speakers and in moderating sessions. After a call for nominations the new ICT expert group was selected. The new group met for the first time in December, hosted by the Swedish Prison and Probation Service in Malmö.

The meeting was attended by representatives from 8 European National Agencies (Ireland, Belgium, Czech Republic, Finland, Croatia, Sweden, Austria, Romania). During the meeting the experts decided to develop papers on 3 topics: case study on telemedicine; best practices and predictions on connecting the inmate to the digital world; and best

practices on internet, cloud and data protection. The group also developed a draft agenda for the EuroPris ICT in Prisons Workshop in 2016 and had a first brainstorm on topics for the 2017 TIC conference.

Some experts of the group decided to support the Polish Prison Service in the organization of a technology conference for public and private sector in mainly Central and Eastern Europe.

#### **Databases**

EuroPris works with two main databases, being the general contacts database and the expert's database. Each year a request to update the current information on experts is sent to the Prison Administrations.

Much effort has been put into building the European Prison Information System (EPIS). EPIS is a web-based digital map of Europe containing operational data of European Prison Services on the national and individual establishment level. Data are accessible for everyone with a Ministry of Justice/Prison Service mail address. EPIS was officially launched at the AGM in June 2014. Since then EuroPris stimulates Prison Services to populate EPIS with data. Amongst others we organized an EPIS training in 2015. By the end of 2015 the system contained the data of 15 jurisdictions.

Next to that the EuroPris Knowledge Management System (KMS) supports inter-agency collaboration and supports European Prison Services who want to put questions on specific topics to a wide network of European colleagues. EuroPris built a system that allows to digitally share these questions with their European network and to produce a structured report within a very short period that is accessible to all respondents. In 2015 EuroPris produced 29 KMS

reports and received a response on each questionnaire from an average of 14 Prison Services. The data collected through KMS were also included in the EPIS for future reference. Both systems are accessible through the EuroPris website.

#### **Projects**

Since 2014 EuroPris started to cooperate in multilateral EU funded cooperation projects. The projects provided for a good opportunity to contribute to activities that are relevant to EuroPris members. The role of EuroPris secretariat was mainly to source experts, to disseminate project results and activities to a wider European audience and to link projects to other activities or initiatives that are taking place on this specific topic in European Prisons and Corrections and specifically in the expert groups and workshops of EuroPris.

In 2015 EuroPris cooperated in 6 projects.

#### 3.2 Position EuroPris in a network of related organisations and European bodies

In Europe a multifold of activities are taking place that are linked to prisons and corrections. EuroPris does not want and cannot take over all that is being implemented by other organisations or initiatives. But as a network organisation EuroPris wants to position itself in such a way that it is aware of other initiatives in the prison area. This is important, not only to prevent duplication of actions taking place, but on the contrary to help making the implemented activities stronger by linking them wherever possible, by supporting the sourcing of experts and by informing a wider group of Prison Administrations. The presence of EuroPris at multilateral events has also helped to increase the visibility of the organisation among European prison professionals.

In 2015 EuroPris was invited to the meeting of all German heads of Prison Services to promote the work of EuroPris and EPIS. At the Victims Support Annual Conference EuroPris used the opportunity to present the work of Prison Services (specifically Scotland) with victims of crime in one workshop. At a roundtable of an American delegation visiting German prisons EuroPris was asked to present the role and importance of EuroPris for European Prison Services. At the anniversary of the Foreign Office of the Dutch Probation Service (one of the founding members of the Special Interest Group on Foreign Nationals in Prison) EuroPris was invited to give a presentation about the work of the FNP expert group. EuroPris participated at the Juvenile Justice Conference in Romania. EuroPris is in an open exchange with the European Prison Education Association (EPEA) and had a meeting with the new chair of EPEA. Participation at the conference in Poland provided for an opportunity to discuss with the Polish Prison Service possible future ways of cooperation. With the European Prison Training Academies (EPTA) discussions are taking place since 2014 about closer cooperation with EuroPris. The Italian chair of EPTA invited EuroPris to join the conference in Rome for further clarification how this cooperation could be established; no final decision was taken. Russia organized for the second time an international penitentiary Forum and invited EuroPris to present at this event. Also, a presentation of EuroPris was requested at the anniversary of the Turkish Probation Service. UNODC participated at the radicalization expert meeting in Vienna and invited in return EuroPris to participate at their expert meeting discussing the scoping document of a handbook.

#### Participation at Penological Council and CDPPC of Council of Europe

In 2015 the experts of the PCCP were asked to work on Guidelines for Prison and Probation Services facing Radicalisation and Violent Extremism. EuroPris observed and provided comments in the drafting process of the Guidelines.

At the 2015 plenary meeting EuroPris was invited to give a presentation about a research into the implementation of the 2012 Council of Europe Recommendation on the treatment of FNP.

In consultation with the Council of Europe the EuroPris Annual Conference and Annual General Meeting were again linked to the Council of Europe Conference of Directors of Prison and Probation Services (CDPPS). EuroPris supported the Council of Europe in defining topics and speakers for the conference.

#### Cooperation in Criminal Justice Platform (CJP)

The Criminal Justice Platform continued in 2015 collaboration with EuroPris, the Confederation of European Probation (CEP) and the European Forum for Restorative Justice (EFRJ).

The CJP met three times in 2015 and all Platform meetings were linked to an activity organized by the Platform. In March a roundtable on the implementation of the EC Victims Directive was organized with representatives of all three organizations and the policy officer of the European Commission. EuroPris was represented by two experts from Croatia and Scotland. With the sudden focus on Radicalisation the Platform decided to change the topic of the Barcelona conference from Drug treatment to Radicalisation. The one day conference with about 100 participants focused on the transfer of violent radical offenders from prison to society. In December the Platform held a seminar in Brussels aiming at EU policy staff to present the status of implementation of the EC Framework Decisions 909/947/829.

As suggested by the EC Cabinet of the Justice Commissioner the Platform approached the chair of the LIBE Committee, Claude Moraes to present the work of the Platform and explore joint interest. Upon his advice both radicalization rapporteurs of the Parliament were invited to the Barcelona conference.

The Platform was supported by the Catalan Ministry of Justice / Centre for Legal Studies in Barcelona by hosting events in their premises and by providing (administrative) support to the Platform through the Platform coordinator.

#### Cooperation with Confederation of European Probation (CEP)

The cooperation with CEP was formalized in an Affiliation Agreement. CEP and EuroPris cooperated on two subjects: staff training and Foreign Nationals in Prison (FNP). On both subjects expert meetings and bi-annual workshops were conducted. At the FNP an expert meeting in the beginning of 2015 it was decided to conduct a research on the implementation of the Council of Europe 2012 Recommendation on Foreign Nationals. On the issue of staff training a workshop was organized in December about the use of e-learning methods. The workshop was attended by 50 participants from about 20 countries.

Next to that CEP cooperated in the organization of the Technology in Corrections conference that was organized in cooperation with ICPA in May in Barcelona.

#### Cooperation with European Commission DG Justice

At the end of 2014 EuroPris submitted two applications to the European Commission. One for the 2015-2017 Framework Partnership Agreement of the Justice Program. The other for the 2015 Operating Grant of the Justice Program. Both applications were approved by the European Commission. In the Framework Agreement a limited number of organizations are selected that will be invited in the course of 3 years to submit an Operating Grant application. Becoming a Framework Partner does not guarantee financing but increases the probability.

In the course of the year EuroPris had some meetings with the European Commission to discuss practical issues and inform them about the work of the organization.

EuroPris kept working on one of the main Commission priorities: the implementation of the Framework Decision 2008/909/JHA on the transfer of prisoners. Another topic that became a top priority of the European Commission

was Radicalisation. Therefore, EuroPris adapted its workplan and established a Radicalisation expert group, organized a one day CJP conference in Barcelona on Radicalisation and Violent Extremism and made this the topic of the panel discussion at the conference preceding the EuroPris Annual General Meeting.

# 3.3 Consolidate EuroPris' position as European representative organisation in the field of Prison and Correctional Services

#### **Membership**

#### Secretariat

EuroPris is registered in The Hague, Netherlands and had one staff member (K. Hawlitschek) working in the EuroPris office at the Dutch Prison Service. Another staff member (R. Popa) worked in the office of EuroPris at

the Belgian Prison Service in Brussels. These two staff members were full time employed. All other staff members worked part time from different locations. One staff member (V. Elliott) was working one day per week from the offices of NOMS in London to support the FD 909 expert group. Two other part time staff supported the organization from their own (organisations) offices in the Netherlands (C. Huisman – financial management) and Belgium (F. Bryans – EPIS and research and statistics). In the Brussels office two interns (C. Ulstad and R. Tarantelli) were working for some months in the course of 2015 to support the local staff member. Also, we started work with a volunteer (N. Hammond) who was a member of the FNP CEP Special Interest Group and who started in 2015 to coordinate the FNP expert group.

Due to this spread of offices and variety of staff EuroPris had direct links to the local Prison Services: Netherlands, Belgium, England, Scotland and Romania. At the same time staff working from different locations required good coordination through regular skype meetings and travel to Brussels, London and The Hague for team meetings. Whenever possible the staff meetings were linked to other events taking place in one of these locations.

The Secretariat benefited from a stable staff situation in 2015 and a slight increase in working force with the deployment of the interns and the volunteer.

#### **AGM**

The National Administration of Penitentiaries Romania co-hosted the fourth EuroPris Annual Conference and General Meeting on 8<sup>th</sup> June in Bucharest. The 78 participants to the conference came from 31 countries, most of them being representatives of European Prison Services. Other participants were from our partner organizations and Council of Europe.

During the conference part in the morning two main issues were addressed. Under the header of radicalization a presentation was given by RAN and the evaluation of a questionnaire (KMS) that was set out by EuroPris to European jurisdictions was presented by the EuroPris President jointly with the Belgian Prison Service. The second

half of the conference was used to present the work of the EuroPris expert groups (FD 909, ICT, FNP, Staff training, Research and Statistics).

At the AGM the Board presented to the members the Annual Report 2014, the Financial Report 2014, the Work plan for 2015 & 2016 and the Budget for 2015 & 2016. All reports were approved unanimously by the EuroPris members. Also, the Board election took place and all nominated candidates were approved and elected by the members.

The AGM was also used to introduce the participants into the work of the multilateral EC funded cooperation projects (STEPS2, Prisons of the Future, IDECOM, ECOPRIS and ERA) in which EuroPris participates. Further, the members were informed about 'Guiding Principles on Private sector involvement' that had been adopted by the Board.

#### Communication

The website <u>www.europris.org</u> is continuously updated and improved. In 2015 there were on average 700 website visitors per month.

The digital bi-monthly newsletter continued to be well received by about 1500 recipients. Next to fixed sections with contributions from Director Generals of Prison Services, Feature Articles, Information about EuroPris activities and projects the newsletter contained information on upcoming events, on relevant documents and news articles.

Through the LinkedIn Group news items from the correctional field were published several times a week. On Twitter EuroPris alerted frequently about activities and penitentiary news. On LinkedIn the EuroPris network contained 314 members and on Twitter EuroPris had 310 followers. The Yammer social network was not much in use in 2015.

EuroPris updated flyers on membership and EuroPris general information and disseminated them during conferences, workshops and seminars to the participants.

#### 4. Organization

#### Registration

On 14 December 2011 EuroPris had been registered in the Chamber of Commerce of The Hague, Netherlands as the European Organization of Prison and Correctional Services (EuroPris) under the CoC registration number 54119715.

#### Staff

The staff of EuroPris worked from several locations - The Hague, Brussels and London.

The President of EuroPris, Hans Meurisse had an agreement with the Belgian Ministry of Justice to work 0.5 day per week for EuroPris in overtime. He was self-employed and paid for his work as President of the Board up to two days a month.

The Executive Director, Kirsten Hawlitschek was employed by the Dutch Custodial Institutions Agency and seconded to EuroPris for 36 hours/week. Her contract was prolonged for another three years 2016-2018.

Fraser Bryans worked for EuroPris on the basis of a service contract. He provided IT support and lead the Statistics and Research expert group and EPIS development for maximum 1 day per week.

Rodica Popa started her work as Office Manager on the  $5^{\text{th}}$  of May 2013 for 32 hours/week as self-employed staff. Since  $5^{\text{th}}$  May 2014 she has a two year service contract for 36 hours/week.

Victoria Elliott replaced Craig Georgiou in the beginning of 2015, seconded from NOMS as an in-kind contribution to EuroPris for 1 day/week. She worked on the Framework Decision 909 expert group.

Carla Huisman was the Financial Manager and worked 0.5 days/week for EuroPris. She was employed by the Netherlands Helsinki Committee and worked on a service contract for EuroPris.

Nick Hammond has started working for EuroPris on 1<sup>s</sup> July 2015. He retired and worked as volunteer on the expert group on Foreign National Prisoners.

#### Finances

EuroPris was awarded in 2015 an EC Framework Partner Agreement and a 2015 Operating Grant.

Out of the total EuroPris Income 2015 of € 396.649 EuroPris requested € 177.778 co-financing from the European Commission. The final amount awarded from the European Commission has not yet been determined.

EuroPris is a membership organization. Members pay a membership fee. The two types of membership have a different type of fee. For Full members the membership fee is calculated on a GDP based model. Depending on the GDP of the jurisdiction it is divided into three fee levels: 3.500 - 6.000 - 7.500 Euro. Affiliate members pay a flat rate of 2.500 Euro.

#### Financial administration and accountant

The financial administration was based at the Netherlands Helsinki Committee with the use of their accounting software (Accountview). Carla Huisman was responsible for carrying out financial administrative tasks and provided EuroPris with financial and tax advice and established the annual financial report. The Executive Director and the Treasurer have both financial responsibility with regard to the execution and approval of payments. The last financial audit of EuroPris took place in February 2016 by Dubois & Co. Registeraccountants. Dubois approved the financial statements for the year 2015 and for the Operational Grant 2015.

#### 5. Finance summary 2015

EuroPris ended 2015 with a positive result of & 97.972.

This result has been:

- 1. added to the continuity reserve for the amount of  $\pounds$  54.455. The Board of EuroPris decided in 2015 September meeting that the maximum reserve that the organisation should build is Euro 120.000. This amount is needed to ensure a further functioning of the organisation in the course of a year without financial support from the European Commission. Further income should be invested in the operation of the organisation. At the end of 2015 the continuity reserve is Euro 120.000.
- 2. added to a special-purpose reserve for the amount of  $\in$  43.518. This reserve will be used to facilitate the participation of representatives of the EuroPris memberstates in the activities organized by EuroPris.

The income for  $2015 - \text{\ensuremath{\&}} 396.649$  - comprises estimated funding from the European Commission  $\text{\ensuremath{\&}} 177.778$  (44,8%),  $\text{\ensuremath{\&}} 131.000$  (33%) from membership fees,  $\text{\ensuremath{\&}} 30.060$  (7,6%) from 'in-kind contributions' and  $\text{\ensuremath{\&}} 57.811$  (14,6%) other income.

Most of the costs - € 298.677 - have been made on staffing arrangements - 56,7 %, travel costs - 20,4 % and Other direct costs - 7,8 %.
