It provides a basis for data backups and extensive data basis for evaluations and central data maintenance. Age and number of children are only collected under the category 'Maintenance obligations'. The main caregiver is not collected. The statistical usability also remains questionable. Knowledge of these data serves the reintegration of the prisoner and the 'achievement of the objectives of the correctional system' as required by the Data Protection Act.	The data is collected during the admission. Usually prison staff collects information through a structured interview.
