International Perspectives on the implementation of the EU's Directive on Victims

Presentation

In June 2013, the CEJFE hosted the first public presentation of the *Criminal Justice Platform Europe* (CJPE), founded by [EUOPRIS](#), the [European Forum for Restorative Justice](#) and the [Confederation of European Probation](#).

A year later, the CEJFE, host another open seminar promoted by the Platform with the objective to examine one of the topics that currently is receiving much attention from the European Union: the promotion and protection of the rights of victims of crimes.

Now, it is the first time that we have an [European Directive](#) that regulates the rights of victims through all the criminal process. It's a challenge shared by Governments and their Administrations, but also by civil society and citizens. The European Directive needs to be transposed and applied across the whole system. In this sense, the Platform wants to approach the Directive from three different views: prisons, probation and restorative justice.

In this seminar we will explain what this Directive indicates in relation to victims and what requires us to do. In this regard, through this seminar we will have the opportunity to examine the current experiences of victims' developments from different European countries and to consider the implications for different criminal justice agencies.
